







#### Manufacturing

- In 2012-2018, Manufacturing had the largest amount of committed FI.
- For Q2 2019, positive contributors to the manufacturing GVA are food manufacturing (6,7%), electrical machinery (16,7%), chemicals (5,4%) basic metal industries (23,4%) and beverages (10,2%).
- In Q2 2019, manufacturing posted a 4% growth.
- Renewed focus on the sector through the Manufacturing Resurgence Program (MRP) initiated by the DTI in 2012.



# Optimal Sourcing Location – global value chain linked automotive & electronics industries

- The Philippines host 21 four wheel assemblers & 25 two wheel assemblers
- The automotive supply chain (excluding the electronics companies) comprises over 380 parts manufacturers – employing 67,000 specialising in metals, machining, plastic, rubber & composite material
- Auto parts generated \$3.5 billion in exports 2017

- The Philippines hosts high profile aerospace first tier suppliers to Airbus and Boeing
- They include United Technologies Corp / Collins Aerospace; Moog Control Systems and Jamco
- Capitalizing on the engineering talent, Lufthansa Technik and Singapore Technologies have established major aircraft MRO (maintenance, repair and overhaul) operations in the Philippines
- The Philippines excels within the electronics sector employing 3.2 million 8 accounts for 11.3% manufacturing GVA
- Electronic exports are likely to exceed \$40 billion for2019
- Companies like Analog Devices have significantly increased their design competences and capacities in the country
- This means that BMW can source from both an established automotive & electronics sector in the Philippines



# US GSP

US President Trump signed into law H.R. 1625 (Public Law 115-141), the "Consolidated Appropriations Act, 2018," extended GSP with retroactivity, for goods entered or withdrawn from warehouse for consumption from January 1, 2018 through December 31, 2020.

Eliminating duties on about 5,000 tariff lines or roughly 47% of 10,600 total US tariff lines.

As of July 01, 2017, 23 Travel Goods tariff lines were added to the program.

- The proposed budget for infrastructure for 2020 amounts to almost Php 1 TRILLION targeted to sustain the new "Build, Build, Build" Program of the current administration
- 75 projects in the pipeline (i.e. road construction, mass transportation and infrastructure sectors) amounting to Php 2,18 TRILLION.


